



Documents required to obtain affordable housing

We thank you for your registration request to obtain affordable housing. In order to be eligible, the applicant must meet the following conditions:

- The applicant must be a resident of the province of Quebec.
- The applicant must be independent (self-sufficient) and capable of providing for his or her own basic needs.
- The family income will have to be sufficient in order to be able to pay the rent at an accessible rate. **Normally, the rent should represent less than 40% of the monthly budget** (proof of income will be required upon a housing offer).
- The applicant must not have any debt with the *Habitations de l'Outaouais métropolitain* or the *Office d'habitation de l'Outaouais*.

Admissibility for Jardins Mont-Bleu only:

The applicant must be a resident of the municipality of Gatineau.

Apartment offer

At the time of the apartment offer, you will have to provide the following supporting documents:

1. Proof of current income;
2. Last year's **provincial** notice of assessment for all members of your family.
3. Proof of current residence (lease, bills, etc.).

We cannot specify at which time we will be able to retain your request for affordable housing. Should you have any questions, you may contact the service de selection at 819-568-0033 ext. 523.
